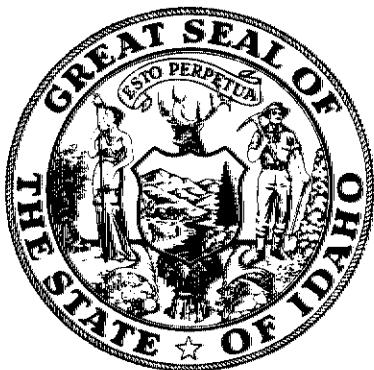

ARTICLE OF INCORPORATION
OF

REBEKAH ASSEMBLY, INDEPENDENT ORDER OF ODD FELLOWS OF IDAHO, INC.

The Rebekah Assembly, Independent Order of Odd Fellows of Idaho, desires to incorporate under the terms of Title 30, Chapter 3, "Idaho Nonprofit Corporation Act."

Articles of Incorporation are as follows:

1--The name of the corporation shall be: Rebekah Assembly, Independent Order of Odd Fellows of Idaho, Inc.

2--This is a nonprofit organization by charter from the Grand Lodge, Independent Order of Odd Fellows of Idaho, Inc., dated October 12, 1892, authorizing the Rebekah Lodges of the Jurisdiction of Idaho to organize a Rebekah Assembly, which was duly instituted and organized at Pocatello, Idaho, on October 12, 1892, for benevolent and fraternal purposes.

3--The period of duration of the corporation to be perpetual.

4--The corporation is organized for the purpose of acting for the membership at large in matters of business, or conveyance of real and/or personal property which may now, or in the future, be held in possession of the Rebekah Assembly, I.O.O.F. of Idaho.

5--The Board of Directors of the corporation shall consist of the President, Vice President, Warden, Secretary, Treasurer, and Junior Past President, who are elected annually at the regular session of the Rebekah Assembly.

6--The registered office of the corporation shall be 920 Grant Ave., Post Office Box 567, Caldwell, Idaho 83606-0567, and the registered agent at that address shall be Carolyn J. Hancock.

7--Meetings of the Board of Directors, named in these articles of incorporation, shall be held at the call of a majority of the directors, or by the President of the Rebekah Assembly, I.O.O.F. of Idaho, for the purpose of transacting such business as may come before the meeting. Three (3) days notice thereof shall be given by mail to each director, stating the time and place of the meeting.
