Brodhead of Hailey, Blaine County, Idaho, do hereby associate ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and for that purpose do hereby make, execute, adopt, sign and acknowledge these articles of incorporation, and declare as follows:

FIRST: The name of this corporation is and shall be "Hailey Hot Springs Hotel Company".

SECOND. The purpose and objects and general nature of the business to be transacted and earried on, for which the corporation is created and organized and the general nature thereof are: To own, possess, have, buy, sell, lease and operate hotels, sanitariums and bathing resorts, farms, dairies, creameries, real estate of every description and wassever situate, hot and cold water rights, pipe lines for both hot and cold water for use in said hotels sanitariums or bathing resorts or otherwise, and to distribute, for profit, natural hot water for culinary, domestic and heating purposes in the City of Hailey, Blaine County, Idaho, in accordance with any franchise which may be granted by said city; to conduct a retail liquor business in connection with any hotel, sanitarium, or bathing resort, emed, leased or operated by it; to borrew money, and to encumber the corporate property and security for the payment therefor; to make, execute, sign and deliver bonds, debentures, bills, promissory notes and mortgages for and of behalf and in the name of this corporation, for the purpose of acquiring, and having

and borrowing money to carry out the objects and purposes for which this corporation is formed and created; to create, issue, execute, buy, and sell stock and bonds of this corporation, and other corporations, and to hypothecate the bonds and stock of this and other corporations as security for money borrowed or other indebtedness for and on behalf of this corporation and other corporations; to de and perform each and all and every act and thing necessary, expedient and proper to carry out the purposes, objects, and business for which this corporation is formed and generally to do and perform any and all acts and other things necessary or useful to successfully carry out and maintain the objects and purposes for which this cerporation is formed and created, and which natural individuals or persons may lawfully do or associate themselves together to perform.

THIRD: The principal place for the transaction of business for this corporation shall be Hailey, Blaine County, Idaho and this corporation may have and maintain an office or offices at Hiawatha, Brown County, Kansas, and such other place or places as the directors of said corporation may see fit to designate, at which said place or places any and all meetings of the directors of said corporation may be held and all business, (except stockholders' meetings) may be transacted and carried on.

FOURTH: The term for which said corporation is to exist is fifty years.

Newlon, C. P. Heimlich, M. M. Gordan and E. J. Bordan, of Hiawatha, Brown County, Kansas, and W. A. Brodhead of Hailey, Blaine County, Idaho.

SIXTH: The amount of capital stock of this corporation is One Hundred Fifty thousand Dollars (\$150,000.) divided into fifteen hundred share of the par value of One Hundred Dollars (\$100.) each.
