AMENDMENT OF THE ARTICLES OF INCORPORATION OF LACLEDE COMMUNITY SUNDAY SCHOOL, INC.

RESOLVED, that the Articles of Incorporation of this corporation, heretofore filed with the Secretary of the State of Idaho, be, and the same hereby are amended in the following manner:

Article III, concerning the Objects and Purposes of the corporation, is amended by adding hereto the following:

- 7. Not withstanding any other provision of these articles or amendments thereto, this corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt under Section 501(c)3 of the Internal Revenue Code of 1954 and its regulations as they now exist or as they may be hereafter be amended. In the event of the dissolution of the corporation or the windup of its affairs, the assets of the corporation shall be distributed exclusively to religious or charitable organizations which would then qualify under the provisions of Section 501(c)3 of the Internal Revenue Code of 1954 and its regulations as they now exist or as they may amended.
- 8. The corporation shall not do or perform any of the following acts:
 - a. Engage in any act of self dealing as defined in Section 4941(d) of the Internal Revenue Code of 1954 or corresponding provisions of any subsequent federal tax laws.
 - b. Retain any excess business holdings as defined in Section 4943(c) of the Internal Revenue Code of 1954 or corresponding provisions of any subsequent federal tax laws.

- c. Make any investments in such manner as to subject it to tax under Section 4944(c) of the Internal Revenue Code of 1954 or corresponding provisions of any subsequent federal tax laws.
- d. Make any taxable expenditures as defined in Section 4945(d) of the Internal Revenue Code of 1954 or corresponding provisions of any subsequent federal tax laws.
