The corporation is formed by the undersigned incorporators as a non-profit organization pursuant to the provisions of the Idaho Nonprofit Corporation Act, with the following as its Articles of Incorporation:

I.

The name of the corporation is Set Apart Discipleship, Inc.
The address is: 1222 N. 6th st, Coeur d'Alene, Idaho, 83814

II.

The corporation is organized exclusively for charitable purposes, including for such purpose the making of distributions to organizations under section 501(c)(3) of the Internal Revenue Code (or corresponding sections of any future Federal tax code). The initial purpose of the corporation is to conduct programs for the rehabilitation of addicts.

III.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributed to, its members, trustees, directors, officers or other private persons, except the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501 (c) (3) purposes.

IV.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) political campaigns on behalf of, or in opposition to, any candidate for public office.

Notwithstanding any other provisions of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from Federal income tax under Section 501 (c) (3) of the Internal Revenue Code (or corresponding section of any future Federal tax code), or (b) by a organization, contributions to which are deductible under Section 170 (2) of the Internal Revenue Code (or corresponding section of any future Federal tax code).

V.

These Articles of Incorporation may be amended by a two-thirds (2/3) vote of the corporation's board of directors provided that a written notice of meeting is delivered to each director not less than ten (10) days prior to the date of the meeting upon which said proposed amendment shall be acted upon, and provided further that the purposed amendment is set forth in the notice of meeting.




Upon the dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meeting of Section 501 (c) (3) of the Internal
