# ARTICLES OF INCORPORATION

OF THE TWIN GROVES WARD

I, the undersigned, having been duly chosen and appointed Bishop of the Twin Groves Ward of the Church of Jesus Christ of Latter-day Saints, in the County of Fremont and State of Idaho, in conformity with the rites, regulations and discipline of said Church, being desirous of forming a corporation for the purpose of acquiring, holding and disposing of Church or religious society property, for the benefit of religion, for works of charity and for public worship, under and pursuant to the provisions of an Act of the Legislature of the State of Idaho, entitled, "An Act providing for the incorporation of churches and religious societies," approved February 14, 1899, for that purpose, do hereby make and subscribe, in duplicate, the following

## ARTICLES OF INCORPORATION:

### FIRST.

The name of this corporation shall be the Twin Groves Ward Corporation of the Church of Jesus Christ of Latter-day Saints.

### SECOND.

The object of this corporation shall be to acquire, hold and dispose of real and personal property, for the benefit of the members of the Church of Jesus Christ of Latter-day Saints, (a religious society,) residing and who may hereafter reside in the Twin Groves Ward of said Church, in the County of Fremont and State of Idaho, for works of charity and for public worship.

### THIRD.

The estimated value of the property of which I hold the legal title for the purposes aforesaid, at the time of making these Articles of Incorporation is \$1500.00 Dollars.

### FOURTH.

The title of the person making these Articles of Incorporation is, Bishop of the Twin Groves Ward of the Church of Jesus Christ of Latter-day Saints, in the County of Fremont State of Idaho.
