

ARTICLES OF INCORPORATION

OF

MINIDOKA COUNTY BABE RUTH ASSOCIATION, INC.

We, the undersigned, do hereby associate ourselves together for the purpose of forming a non-profit corporation under the Statutes of the State of Idaho.

FIRST: The name of the corporation is Minidoka County Babe Ruth Association, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which this corporation is organized is to promote and provide a baseball league young men between the ages of 13 and 15 years, and for all related purposes.

FOURTH: The corporation shall have as members all parents of the young men who participate in the Babe Ruth Baseball League in Minidoka County, Idaho.

FIFTH: Provisions for the regulation of the internal affairs of the corporation are:

Section 1. Meetings of Board of Directors. Meetings of the Board of Directors of Minidoka County Babe Ruth Association, Inc. may be held at such places, in the State of Idaho, as may be provided in the Code of By-Laws. In the absence of any such provisions, all meetings shall be held at the registered office of the corporation.

Section 2. Code of By-Laws. The initial Code of By-Laws of the corporation shall be adopted by its Board of Directors and shall become effective upon adoption. The power to alter, amend or repeal the Code of By-Laws or to adopt a new Code of By-Laws shall be contained in the Code of By-Laws and the Code of By-Laws may contain any provisions for the regulation and management of affairs of the corporation not inconsistent with the Act, or these Articles of Incorporation.

Section 3. Amendments of Articles of Incorporation. The corporation reserves the right from time to time to amend, alter or repeal, or to add any provision to, its Articles of Incorporation, in any manner now or hereafter prescribed or permitted by the provisions of the Act, and any amendment thereto, or by the provision of any other applicable statute of the State of Idaho, and all rights conferred upon the Board of Directors by the Articles of Incorporation, or any amendments thereto, are granted, subject to this reservation.

SIXTH: The address of the initial registered office of the corporation is Rt. 2 Box 526 and the name of the initial registered agent at such address is Micheal V. Bott.

SEVENTH: The number of directors constituting the initial Board of Directors of the corporation is three (3), and the names and addresses of the persons who are to serve as directors until the first meeting of the Board of Directors as a corporation or until the successors are elected and shall qualify are:
