ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I.

FIRST: The name of the corporation is STOPLITE, INC..

ARTICLE II.

SECOND: The period of said corporation's duration shall be perpetual.

ARTICLE III.

THIRD: This corporation is formed for the purposes of conducting and transacting any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, including, but not limited to the ownership and operation of restaurant, and places for the retail sale of alcoholic beverages.

ARTICLE IV.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is thirty thousand (30,000), which shares shall have a par value of One Dollar (\$1.00).

ARTICLE V.

FIFTH: Provisions for the regulation of the internal affairs of the corporation shall be set forth in the By-Laws

of the corporation as from time to time may be amended or adopted.

ARTICLE VI.

SIXTH: The address of the initial registered office of the corporation is 2712 Edson Street, Boise, Idaho 83705, and the name of its initial registered agent at such address is Gustaaf J. Boonen, Jr..

ARTICLE VII.

SEVENTH: The number of directors constituting the initial board of directors of the corporation is one, and the name and address of the person who is to serve as director until his successor is elected and shall qualify is:


