

**ARTICLES OF INCORPORATION

The undersigned, acting as the incorporator of a nonprofit corporation ("Corporation") organized under and pursuant to the Idaho Nonprofit Corporation Act, Chapter 3, Title 30, Idaho Code ("Act"), adopts the following Articles of Incorporation ("Articles")

ARTICLE I**NAME OF THE CORPORATION**

The name of the Corporation is the League of Women Voters of Idaho Education Fund, Inc.

ARTICLE II**STATUS**

The Corporation is a nonprofit corporation.

ARTICLE III**PERIOD OF DURATION**

The period of duration of the Corporation is perpetual.

ARTICLE IV**REGISTERED OFFICE AND AGENT**

The location of the corporation is in the City of Coeur d'Alene, County of Kootenai, and in the State of Idaho. The address of the initial registered office, and the name of the initial registered agent at this address is Judy Edwards, 702 W. Walnut St. # 207, Coeur d'Alene, ID 83815.

ARTICLE V

PURPOSES

The purposes for which the Corporation is organized and will be operated are as follows:

- A. To create and offer to the general public programs, literature and presentations for voter education.
- B. To conduct nonpartisan educational meetings, forums and discussion groups on topics of general public interest. We would present the complete, unbiased facts sufficient for a person to form an independent opinion or conclusion.
- C. To provide nonpartisan information about candidates for public office and ballot issues through a variety of mediums and public meetings.
- D. To exercise all powers granted by law necessary and proper to carry out the foregoing purposes, including, but not limited to, the power to accept donations of money, property, whether real or personal, or any other items of value. The purpose of the corporation shall be limited exclusively to one or more of the exempt purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986 or corresponding provisions of any future United States Internal Revenue Code or federal revenue law.

ARTICLE VI

LIMITATIONS

No part of the net earnings or the assets of the Corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons except that the Corporation shall be authorized and empowered to pay reasonable compensations for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article V hereof. No part of the activities of the Corporation shall be for the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing and distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provisions of the Articles, the Corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501c (3) of the Internal Revenue Code of 1986, as amended from time to time.

ARTICLE VII

MEMBERSHIP

The corporation shall not have any members.

ARTICLE VIII

BOARD OF DIRECTORS

The Affairs of the Corporation shall be managed by its Board of Directors. The number of Directors serving on the Board of Directors shall be fixed in accordance with the Corporation's Bylaws, which number shall be no less than three. Other than the Directors constituting the initial Board of Directors, who are designated in these Articles, the Directors shall be elected by the existing Directors of the Corporation in the manner and for the term provided in the Bylaws of the Corporation.

ARTICLE IX

DISTRIBUTION ON DISSOLUTION

Upon dissolution of the Corporation, the Board of Directors shall, after paying or making provision for the payment of all liabilities of the Corporation, distribute all the assets of the Corporation to the League of Women Voters Education Fund, so long as it qualifies as an exempt organization under Section 501 (c) (3) of the Internal Revenue Code. Any such assets not so distributed shall be distributed by the district court of the county in which the principal office of the Corporation is then located, exclusively for the purposes or to such organizations, such court shall determine to be consistent with the purposes of the Corporation.

ARTICLE XI BYLAWS

Provisions for the regulation of the internal affairs of the Corporations shall be set forth in the Bylaws. The Board of Directors of the Corporation shall be authorized to amend the Corporation's Bylaws at a properly noticed special or regular meeting of the Board of Directors.
