

AFTICLES OF INCORPORATION

OF THE

TRI-COUNTY HADIO CORP.

John J. Hurley, and Faul R. Dorff, residents of the State of Montana, do by these presents, pursuant to and in full compliance with the laws of the State of Wontana, associated ourselves and adopt the following articles of incorporation for the purpose of creating a corporation in compliance with the constitution and the laws of the State of Wontana.

ARTICLE I

The objects and purposes for wich this corporation is formed is for the carrying on of a general radio broadcasting business, the transmitting of radio, wireless, telephone, frequency modulation, music, speeches, advertising, and all types of programs both original and recorded, or retransmitted by shortwave, telephone, direct wire, or other means now known or to be devised later, and the operation of studios, broadcasting stations, machinery, equipment, electric power plants, transportation facilities necessary and convenient to conduct such business, and laboratories for experimental work.

To borrow money and make, draw, accept, endorse, issue and negotiate promissory notes, bills of exchange, drafts, appearances, bonds and other obligations and swidences of indebtedness of any and all kinds and to secure the same by mortgage, pledge or otherwise.

To loan money for profit, to take hold and receive security therefor and to do business on a commission basis or otherwise.

rical equipment of all kinds and cheracter or other property sequired by the corporation for cash or credit and to barter, exchange or otherwise acquire or dispose of wireless, radio, telephone, frequency modulation, electronic equipment and general merchandise or other property owned or acquired by the corporation and to do all lawful things necessary and convenient in financing such sales or exchanges.

To purchase, hold, improve, use, lease, sell, construct and operate gas works, electric lighting plants, lines, and wires both above and under the ground, machinery, and transmitting electricity, as, electric energy, electric light, heat, power, communication lines, and wires both above and under the ground and other uses, and to acquire, hold, manage, and operate buildings, machinery, pipelines, transmission lines and wires, for electricity and communications, both above and under the ground and other appliances for manufacturing products and distributing gas, electricity and communications and all other illuminative products to which they maybe applied, and to supply

such power, light, heat, gas, electricity, and illuminative products and communications, to mills, factories, villages, towns, cities, rural communities, and to the inhabitants thereof, and to the public generally or to any other useful or beneficial purpose.

To experiment in radio, television, frequency modulation, and other forms of wireless transmission and to make application, hold, own, purchase, and sell patents and patent rights, in improvements and developments in radio transmission, electronics, radio television receiving and broadcasting, and to manufacture and sell articles, methods, means, and developments useful in radio, television broadcasting and receiving, electronics and other electrical products.

AFTICLE II

The name of this corporation shall be:

TRI-COUNTY RADIO COFP.

AFTICLE III

The place where the principal business of the corporation is to be transacted and where its principal place of business is located is Shelby, Montans, in Toole County, and such other places as may be ordered by the Board of Tirectors of such corporation from tire to time.

ARTICLE LY

That the term for which this corporation is limited, is forty (40) years from and after the date of its incorporation and for such further period of time as may be suffer ised by law.

AFTICLE V

That the number of directors of this corporation; whall be three (3) and the names and residences of the three who shall serve until the first meeting of the stockholders for the purpose of electing a regular Board shall be:






