The Corporation will engage in 501(c)(3) activities such as conducting research and educating the public on issues related to family and domestic violence, sexual assault, dating violence, and stalking ("the issues"); providing professional legal resources to law enforcement and prosecuting authorities within rural communities in Southeastern Idaho engaged in combatting the issues; and/or representing victims of the issues throughout criminal proceedings. Advocacy will primarily focus on crimes which have been perpetrated against women and children within participating counties located in rural Southeastern Idaho.
