ARTICLES OF INCORPORATION

of

BONNERS FERRY CHRISTIAN RADIO TRANSLATOR, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, have this day voluntarily associated ourselves together for the purposes of forming a non-profit corporation under the provisions of Title 30, Chapter 11, IDAHO CODE, and amendments thereto, and we hereby certify as hereinafter stated.

ARTICLE I.

The name of said corporation shall be BONNERS FERRY CHRISTIAN RADIO TRANSLATOR, INC.

ARTICLE II.

The purposes for which it is formed are:

To promote and maintain a Christian MBI radio broadcasting activity in Boundary County, Idaho, and surrounding areas and to assist with said broadcasts and repeat transmission in Bonners Ferry and Boundary County, Idaho, and surrounding areas.

To promote events and facilities relating to improving and establishing Christian radio communications of any and all acts relating thereto; also, to establish and promote benevolent and recreational activities relating to MBI radio broadcast activities of any kind whatsoever.

ARTICLE III.

The place where its principal business is to be transacted shall be at Bonners Ferry in Boundary County, Idaho.

ARTICLE IV.

The activities of the corporation shall be limited to carrying on of only those activities permitted to be carried on (a) by a corporation exempt from Federal Income Tax under Section (c) (3) of the Internal Revenue Code of 1954 (or the corresponding provisions of any future United

States Internal Revenue Law), or (b) by a corporation, contributions to which are deductible under Section 170 (c)(2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

ARTICLE V.

Under the dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501 (c)(3) of the Internal Revenue Code of 1954 (or the corresponding provisions of any future United States Internal Revenue Law), as the Board of Directors shall determine. Any of such assets not so disposed of shall be disposed of by the District Court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE VI.

The time for which this corporation is to exist is not limited, but it shall exist perpetually, unless dissolved according to law.

ARTICLE VII.

The location and post office address of the registered office of this corporation in this State, and principal place of business shall be 221 West Madison, P. O. Box 526, Bonners Ferry, Idaho 83805. The statutory agent for Idaho shall be: James K. Greenslitt, P. O. Box 526, Bonners Ferry, Idaho 83805.

ARTICLE VIII.

The number of its directors shall be five (5)

and the names of those directors who shall manage the affairs of the corporation for a period of one year from the date of incorporation or until the successor directors shall be elected by the members are:

ARTICLE IX.


This corporation is not organized for profit and shall have no capital stock.


The Board of Directors shall have the power to issue certificates of membership in the various classes to be signed by the president and the secretary of the corporation.
