CERTIFICATE OF LIMITED PARTNERSHIP

 - (C) To act on own account for others. To accomplish any of the foregoing purposes for its own account or as a nominee, agent or trustee for other individuals, partnerships, corporations or other intities.

11. Right to Receive Property Other Than Cash.

No limited partner is given the right to demand and receive property other than cash in return for his contribution, except that, upon dissolution of the partnership if the general partners deem it in the best interests of the partnership, they may distribute assets 31 of the partnership to the partners in kind.
