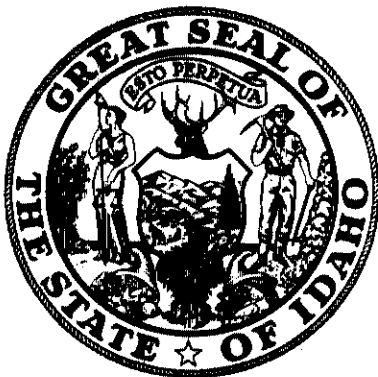
**CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION
OF
STOKES 59, INC.

The undersigned, who are natural persons of full age and citizens and residents of the State of Idaho and the United States of America, for the purpose of forming a corporation under the laws of the State of Idaho, hereby certify and declare:

ARTICLE I

The name of this corporation shall be Stokes 59, Inc.

ARTICLE II

The purposes for which it is formed is distributing and selling to the public, groceries, all types of commodities and such items as may be in public demand and any and all legal purposes and activities for which corporations can be organized.

ARTICLE III

The duration of the corporation shall be perpetual.

ARTICLE IV

The location of the corporation and its initial registered office is 539 Overland Avenue, City of Burley, County of Cassia, State of Idaho, 83318. The initial registered agent at such address shall be John Stokes.


