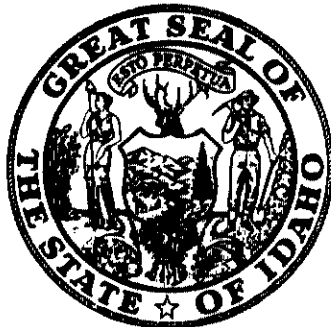
### CERTIFICATE OF INCORPORATION OF

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation:

**ARTICLE I**

The name of the corporation is Frank Construction, Inc.


