The undersigned, duly licensed to practice dentistry in the State of Idaho desires to form a professional corporation pursuant to Idaho Code § 30-1301 et seq., for the purpose of rendering dental services and adopt(s) the following Articles of Incorporation for such corporation:

ARTICLE I

NAME

The name of this corporation shall be WESTWIND DENTAL P.A..

ARTICLE II

PURPOSE

The purpose(s) for which this corporation is formed is to engage in the general practice of dentistry.

In connection with the practice of dentistry, the corporation shall have the power to invest its funds in real estate, mortgages, stocks, bonds or any other type of investments, and to dispose of the same; and, to own real and personal property necessary for the rendering of professional services.

In addition, said corporation may engage in any activity permitted under Chapter 13 of Idaho Code § 30-1301 et seq.

persons who are licensed to practice dentistry within the State of Idaho.


ARTICLE VI
