The undersigned, in order to form a corporation pursuant to the Idaho Business Corporation Act, certify as follows:

ARTICLE I

The name of the corporation is Dick's Mobile Service, Inc. (hereafter referred to as corporation.)

ARTICLE II

The purposes for which this Corporation is organized are as follows:

1. To repair and remodel homes; and
2. To use pressure washing in cleaning exteriors; and
3. To engage in any other lawful activity or business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE III

The Corporation shall have perpetual existence.

ARTICLE IV

The address of the initial registered office of the Corporation shall be 9833 Barnsdale Drive, Boise, Idaho 83704, and the name of its initial registered agent at such address is Richard Lee Storkson.
