We, the undersigned, natural persons over the age of eighteen years and citizens of the United States, do this day voluntarily form a service corporation under the laws of the State of Idaho, as contained in Chapter 1 of Title 30, Idaho Code, entitled "General Business Corporation Act" and to that end we certify in writing:

ARTICLE I
NAME

The name of the corporation shall be ROCKY MOUNTAIN TECHNOLOGY & CONSULTING, INC.

ARTICLE II
PURPOSE AND POWERS

The purposes for which this corporation is organized are:

- (a) To engage in the business of Internet management, consulting, and design, and any other lawful business.
- (b) To invest funds in real property, personal property, mortgages, stocks, bonds or any other types of investments and to own or lease real or personal property necessary for the rendering of such business; and
- (c) To engage in such other businesses which may be authorized or permitted by the General Business Corporation Act any lawful act or activity for which corporations may be organized under the Idaho Business Corporation Act (Chapter 1 of Title 30, Idaho Code) and to the extent not inconsistent with the foregoing as may be permitted by the Idaho Business Corporation Act (Chapter 1 of Title 30, Idaho Code).

ARTICLE III DURATION

Subject to dissolution in the manner provided by law, the corporation shall be perpetual.

ARTICLE IV REGISTERED OFFICE

The registered office of the corporation in the State of Idaho shall be located at 104 Lincoln Street, Twin Falls, Idaho 83301. Eric R. Clark shall be the registered agent at the address set forth above.

ARTICLE V CORPORATE STOCK

The aggregate number of common shares which the corporation shall have authority to issue is ten thousand (10,000), which shall have a \$1.00 par value.


shall serve as the initial board of directors until the first annual meeting of shareholders or until their successors are elected and qualified.
