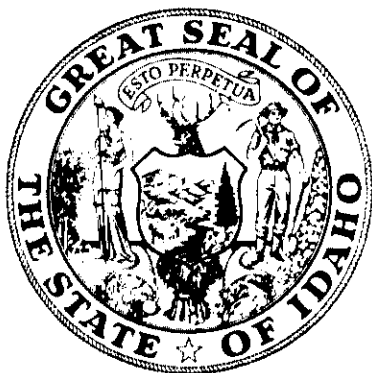

ARTICLES OF AMENDMENT TO
THE ARTICLES OF INCORPORATION OF
LEWIS-CLARK TERMINAL ASSOCIATION, INC.

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is LEWIS-CLARK TERMINAL ASSOCIATION, INC.

SECOND: The following amendments to the Articles of Incorporation were adopted by the shareholders of the corporation on May 17, 1982, in the manner prescribed by the Idaho Business Corporation Act:

Article FIRST of the Articles of Incorporation be, and the same hereby is, amended as follows:

FIRST: That the corporate name of this corporation shall be LEWIS-CLARK TERMINAL, INC.

Article NINTH of the Articles of Incorporation be, and the same hereby is, amended as follows:

NINTH: That the right and power to repeal, alter, rescind and amend the bylaws of this corporation and to adopt new bylaws is hereby expressly conferred solely upon the shareholders of this corporation.

THIRD: The number of shares of issued and outstanding capital stock of the corporation is 745,102 shares and the number of shares entitled to vote upon the amendment is 745,102.

FOURTH: The number of shares voting for the amendment

was 703,797 shares and no shares voted against the amendment.
