

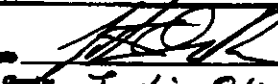

INSTRUCTIONS FOR THE IDAHO ANNUAL REPORT FORM

- 1) Please pay special attention to the mailing address. If it is incorrect, please make the appropriate correction.
- 2) NOTE: The name of the business entity cannot be altered on the annual report form.
- 3) If the registered agent has changed or moved, please state that correction on this form. The registered agent must be listed in ICAPIC as a PHYSICAL ADDRESS. PO Boxes WILL NOT be accepted. If report is for a Limited Liability please refer to 6a below.
- 4) Corporation: Enter name and address of ONLY the president, secretary, and director in block 4.
- 5) Limited Liability Company: Enter the name and address of the manager or members in block 4.
- 6) NOTE: Filing "same as last year" WILL NOT be accepted.
- 7) Limited Liability Company: If the registered agent has been changed in block 2, then the NEW registered agent must accept that position by signing in block 5.
- 8) Corporation: Block 5 must be signed by an officer or chairman of the board of the corporation. Officer must specify his or her title.
- 9) Limited Liability Company: Block 5 must be signed by a manager or member, who must specify his or her title.
- 10) If new registered Agent, please sign block 5.
