PLAN OF MERGER

Pursuant to § 30-18-202 of the Idaho Code, the following constitutes the Plan of Merger for the purpose of merging Munsey-Featherston Family Salmon River Retreat, Inc., into Featherston Salmon River Properties, LLC.

FIRST: The Surviving Entity is Featherston Salmon River Properties, LLC a limited liability company formed under the laws of Idaho, currently in good standing, whose Certificate of Organization was filed with the Idaho Secretary of State on May ____, 2015.

SECOND: The Disappearing Entity is Munsey-Featherston Family Salmon River Retreat, Inc., a corporation formed under the laws of Idaho, currently in good standing, whose Articles of Incorporation were filed with the Idaho Secretary of State on January 3, 2002.

THIRD: The effective date of this merger shall be the date the Statement of Merger in this matter is filed with the Idaho Secretary of State.

FOURTH: Both the Surviving Entity and the Disappearing Entity are currently owned equally by the same three persons, and, after the merger contemplated herein, the Surviving Entity shall continue to be owned equally by the same three persons. Thus, the shareholders of the Disappearing Entity shall receive no new ownership units in the Surviving Entity, and, upon tender of all of their shares in the Disappearing Entity, said Munsey-Featherston Family Salmon River Retreat, Inc. shall cease to exist, all of its property shall become the property of Featherston Salmon River Properties, LLC, and all liabilities of Munsey-Featherston Family Salmon River Retreat, Inc. shall become liabilities of Featherston Salmon River Properties, LLC.

FIFTH: This merger does not require an amendment to the Certificate of Organization or any other public organic document of the Surviving Entity.

SIXTH: By their signatures below and pursuant to §§ 30-1-704 and 30-1-821 of the Idaho Code, undersigned, being all of the shareholders and directors of Munsey-Featherston Family Salmon River Retreat, Inc., hereby unanimously authorize and direct the appropriate corporate officers to effectuate this merger.

SEVENTH: By their signatures below and pursuant to §§ 30-6-407(2)(d) and 30-6-302(1)(b)(ii) of the Idaho Code, the members of Featherston Salmon River Properties, LLC, a member-managed LLC, hereby unanimously (a) authorize this merger and (b) authorize and direct the LLC members to effectuate the plan stated herein.
