## CERTIFICATE OF EXTENSION OF CORPORATE EXISTENCE OF PEOPLES CANAL & IRRIGATION COMPANY

We, the undersigned, A. K. Van Orden, President, and Boyce Benson, Secretary, and A. K. Van Orden, Frank Bailey, C. L. Williams, Ralph Clough, D. L. Murdock, Adolph Tressel and Boyce Benson, being and constituting the Board of Directors of Peoples Canal & Irrigation Company, a corporation organized and formerly existing under and by virtue of the laws of the State of Idaho, do hereby certify as follows:

That Peoples Canal & Irrigation Company was so incorporated on the 13th day of March, 1895, and the term of its corporate existence set forth in its Articles of Incorporation was a period of fifty years from said date of incorporation.

That heretofore the stockholders of said corporation owning and representing more than two-thirds of the capital stock of this corporation each gave their written assent to the extension of the corporate existence of said corporation to perpetual existence from March 13th, 1945, and therein authorized and empowered the officers and the Board of Directors of the corporation to take any and all necessary legal steps to procure such extension, to pass any resolutions and to furnish the necessarycertificates or documents to evidence such extension, said written assents being in all respects pursuant to law, which assents were duly and regularly filed by the Secretary of the corporation in its corporate records as by order of the Board of Directors provided and pursuant to the said written authorization and upon the holding of the regular meeting of the Board of Directors at the office of the corporation at Blackfoot, Idaho, on December 15th, 1951, the following resolution was duly presented, put and carried unanimously, to-wit:

"NOW, THEREFORE, BE IT RESOLVED, That pursuant to written assents of the stockholders owning and representing more than two-thirds of the capital stock of this corporation and the authority granted in such written assents to the Board to pass any and all necessary resolutions to carry into effect the written assents, to provide for the proper execution of any certificate or document necessary to effect such extension, that Peoples Canal & Irrigation Company hereby extends the term of its corporate existence as provided by law for the period of perpetual existence from and after the 13th day of March, 1945, and that the proper officers of this corporation and the necessary members of the Board of Directors of this corporation be and they are hereby authorized and empowered to sign and verify any certificate or document which may be necessary or proper to evidence the action taken by the stockholders and Board of Directors of this corporation to secure the extension of the term of corporate existence, as stated."

We do further certify that on due and regular canvass of the assents of the stockholders to such extension of corporate existence it was found that the stockholders of such corporation owning and representing more than two-thirds of the capital stock of this corporation had in writing given their assent to such extension of the corporation existence of the corporation, and had authorized the officers and Board of Directors of the corporation to take any and all necessary legal steps to procure such extension and to furnish the necessary certificates or documents to evidence such action for extension, the capital stock of this corporation as authorized and issued being 20,000 shares and the canvass of written assents showing that the owners of the shares to the number of 14,153 had so given their written assent to the extension of the term of corporate existence perpetually from March 13th, 1945.

That the foregoing is a full, true and correct statement of the proceedings of the stockholders with reference to the written assents to the extension of the corporate existence of the corporation and of the meeting of the Board of Directors at which said resolution was passed, approved and adopted.
