- I, the undersigned natural person of the age of 21 years or more, acting as incorporator under the Idaho Business Corporation Act, adopt the following Articles of Incorporation:
- ARTICLE I. The name of the corporation is CENTRAL IDAHO EQUITIES, INC., and its duration shall be perpetual.

ARTICLE II. The initial registered office of the corporation in the State of Idaho is 12413 S. Swallowtail Lane, Boise, Idaho 83706 and the initial registered agent for the corporation is Stan Potts.

ARTICLE III. The purpose and powers of the corporation are:

- 1. To engage in the business of real estate development.
- 2. To engage in any lawful activity for which corporations may be organized under Idaho Code, Chapter 30.
- 3. To engage in any lawful activity and to do anything in the operation of this corporation or for the accomplishment of any of its purposes or for the exercise of any power herein set forth which shall appear necessary or beneficial to this corporation in connection therewith.

ARTICLE IV. The amount of total authorized capital of this corporation shall be:

- 1. 100 shares of common stock at no par value.
- 2. No shareholder shall have the preferential or preemptive right to subscribe for or purchase any stock of any class, any ARTICLES OF INCORPORATION - 1

rights, warrants or options with respect thereof, or any obligation convertible unto or exchangeable for any such stock or other security whether out of unissued stock or other securities or out of stock or other securities acquired by the corporation after the issue thereof, regardless of the consideration therefor.

3. Each shareholder shall have one vote for each share held of record on all matters submitted for shareholder approval. No shareholder shall be entitled to cumulate his votes for election of directors.

ARTICLE V. The members of the governing board shall be known as directors, and the number thereof shall be fixed by the bylaws of this corporation. The initial board of directors shall consist of (1) director, whose name and address are:
