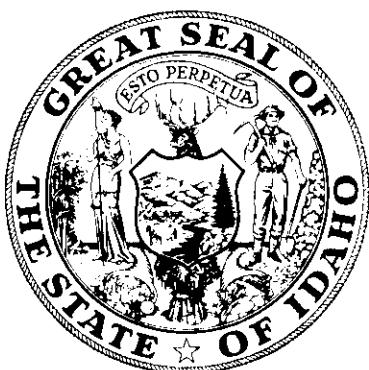

Under Title 30, Chapter 1 of the Idaho Business Corporation Act

I, THE UNDERSIGNED, being of legal age, for the purpose of forming a corporation pursuant to the Business Corporation Act of the State of Idaho, do hereby certify:

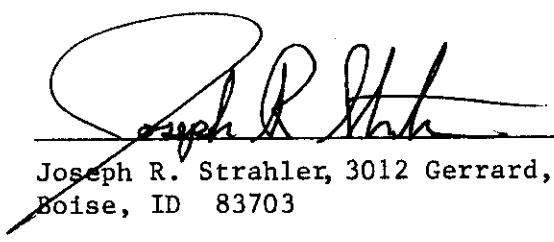
