KNOW ALL MEN BY THESE PRESENTS:

SEARETARY OF STATE

That pursuant to the provisions of Idaho Code, Section 30-1-145, Reeder Flying Service, Inc., an Idaho Corporation, by and with the unanimous consent of all of its shareholders on January 1, 1983 amends Article V of its Articles of Incorporation as follows:

That the authorized capital stock of this corporation shall be \$300,000.00 divided into 3,000 shares of a par value of \$100.00 each and that the total authorized numbers of shares shall be 3,000 and their total par value \$300,000.00. No share of this corporation when issued and fully paid for shall be subject to assessment.

Except for the above change the original Articles of Incorporation of this corporation and the matters set forth and recited therein are in all respects valid and subsisting and unaffected thereby.
