Amendment of Articles of Incorporation for Athol Baptist Church, Inc.

The text of the article being amended:

ARTICLE II

The object, business and purpose of this corporation is non-political and non-profit and this corporation shall not engage in any form of trade or commerce or carry on any activity which would result in loss of its designation as a non-profit religious corporation pursuant to Idaho state law. Subject to the foregoing limitations, the object, business and purpose of this corporation shall be as follows:

To promote the teachings and proclaim the gospel of Jesus Christ through worship services, education, community events and other activities as deemed necessary by the corporation's Board of Directors and in accordance with the Statement of Beliefs of the corporation.

This corporation shall, within the limitations imposed by the provisions for non-payment corporations under the laws of the State of Idaho, have the power to buy, sell, receive, acquire, hold, possess, manage, dispose of and convey such real and personal property which has now or may hereafter be acquired for the use and benefit of the Church, or any institutions which the Church may own, maintain or operate; to have and exercise the power to mortgage, pledge and hypothecate any or all of the real and personal property belonging to it as security for money borrowed or obligations which may be incurred in the purchase, maintenance, improvements or in the conduct of its work; to receive and collect funds and cash, real and personal, by will, contribution, donation or otherwise for the support and maintenance of the Church and its work in general. This corporation shall within the limitations imposed for non-profit corporations under Idaho state law have the full authority and power to do each and every other lawful act in furtherance of its goals, as permitted by Idaho law.

The Church covenant heretofore adopted by the charter members of this Church is hereby unanimously adopted as a covenant of this Church corporation and shall be maintained on the minute books of this Church corporation.


