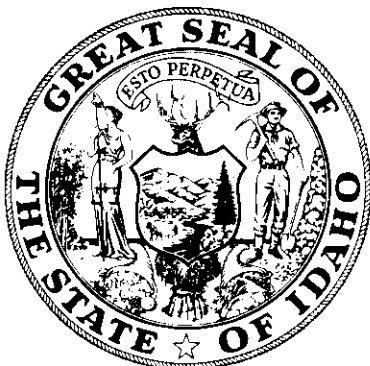

**ARTICLES OF INCORPORATION**

of

The undersigned, acting as incorporator of a corporation under the laws of the State of Nevada, adopts the following Articles of Incorporation for such corporation:

I.

The name of the corporation is PAWA INCORPORATED of Nevada.

II.

The corporation is to have perpetual existence.

III.

The corporation is organized for the purpose of performing consulting services and all activities incident or related thereto and for the purpose of transacting any or all lawful business for which corporations may be incorporated under the laws of the State of Nevada.

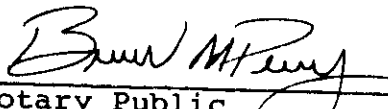
