13. The general partners have the right to make distributions to partners in their sole discretion.


14. The partnership shall be dissolved upon the sale of the partnership assets at such time as the general partners may determine but in no event later than February 3, 1994.


15. The remaining general partners shall have the right to continue the partnership business upon the withdrawal of one of the general partners.


