I, the undersigned, incorporator for the purposes of forming a corporation under and pursuant to Title 30, Chapter 3 of the Idaho Code do hereby certify the following:

I.

The name of the Corporation shall be:

II.

The Corporation is a non-profit corporation.

III.

The duration of this Corporation shall be perpetual. Upon dissolution, the assets shall be distributed to an organization in Kootenai County, Idaho, chartered by Little League Baseball, Incorporated.

The purpose of this Corporation is to promote, encourage and manage youth baseball in Coeur d'Alene, Idaho, under a charter granted by Little League Baseball, Incorporated.
