ARTICLES OF INCORPORATION OF

THE WHOLESALERS OF NAMPA, INC.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, all of whom are of full legal age and bona fide residents of the State of Idaho, and citizens of the United States, and who desire to and have this day voluntarily associated ourselves together for the purpose of forming a corporation under and by virtue of the laws of the State of Idaho, and we do hereby certify as follows:

ARTICLE I.

That the name of this corporation is THE WHOLESALERS OF NAMPA, INC.

ARTICLE II.

That the purposes for which and for any of which this corporation is formed are:

1. To sell either retail or wholesale or as brokers, all kinds of seed, grain, cottonseed meal, meal of any type or kind and any other articles manufactured from grain or cereals and the products and by-products thereof, livestock feed of any type and to carry on such other business, operations and transactions as are incidental to the general milling, manufacturing, or handling of all kinds of seed grain or cereals and all types of commercial fertilizers, and to do commercial transporting thereof.

2. For the above purpose said corporation shall have the power to acquire, build, lease, own and operate in connection with its business such offices, mills, warehouses, elevators, and have such other structures as may be necessary for the carrying on of such business and for the buying, selling, storing and handling any of the products herein set out.

3. To purchase, take, lease, exchange, hire or otherwise acquire, any real and personal property or any rights or privileges therein, which this corporation may think necessary and convenient for the purpose of its business, and to buy, own and hold real property for the purpose of its business, and to buy, own and hold real property for the purpose of securing debts due to the corporation, and to sell and dispose of the same at will.

4. To purchase holdings, sell and transfer shares of its own stock, and capital stocks, bonds or other obligations of any other corporation received by it from time to time to such extent and in such manner and upon such terms and conditions as the board of directors of this corporation shall determine in order to promote the purposes of this corporation.

5. To issue shares of stock of this corporation for cash, or other property, tangible or intangible, or necessary services actually rendered, or labor done.

ARTICLE III.

That this corporation shall have perpetual existence.

ARTICLE IV.

The location and post-office address of its registered office in the State of Idaho shall be MANA, IDAHO.

ARTICLE V.

That the amount of capital stock of this corporation is \$25,000.00 and the number of shares into which the same is divided is **two hundred fifty** of the par value of \$100.00; that such capital stock shall be classified as Common Stock; and each share of common stock shall have the same rights and shall be in all respects equal to each other as share of common stock and shall have equal and full voting rights in said corporation.

ARTICLE VI.

That the number of directors of this Corporation shall be three and the names and post-office address of each of the incorporators and a statement of the number of shares of common stock subscribed by each of them are as follows:
