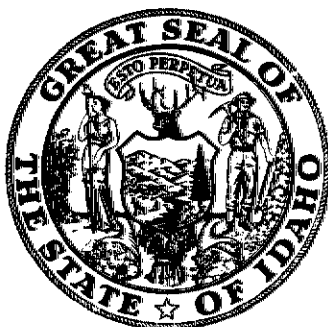

KNOW ALL MEN BY THESE PRESENTS, that Tamrak, Inc. on this day voluntarily formed a corporation under the laws of the State of Idaho, and hereby adopt Articles of Incorporation as follows:
