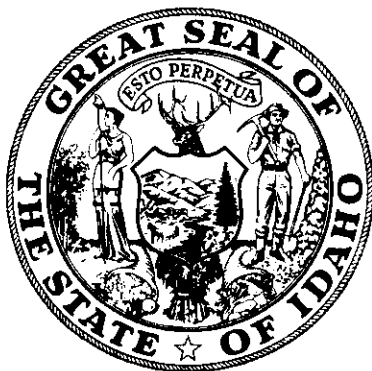

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE: NAME

The name of the corporation is Guardian Heating & Air Conditioning, Inc.

ARTICLE: DURATION

The period of its duration is perpetual.

ARTICLE: PURPOSE

The purposes or purposes for which the corporation is organized are: for the stocking of appropriate merchandise, including parts, the sale, maintenance, repair and installation of heating and air conditioning equipment, and all other services related thereto, and the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
