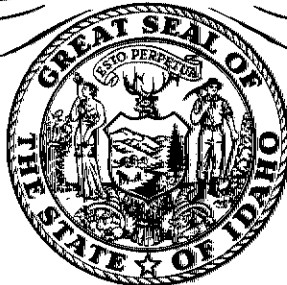

ARTICLES OF INCORPORATION  
OF  
GORDON PAVING COMPANY, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, being all natural persons of legal age and all citizens of the United States and all residents and citizens of the State of Idaho, in order to form a corporation for the purposes hereinafter stated, pursuant to the statutes of the State of Idaho, do hereby certify as follows:

1.

The name of the corporation is Gordon Paving Company, Inc.

2.

The purpose for which said corporation is formed are as follows:

To conduct a general construction business including all types of paving, grading, excavating and the production and sale of all kinds of gravel, land planing and leveling together with all businesses allied therewith. ✓  
Generally to undertake and transact any business of contracting or construction. To Purchase, lease, exchange, or otherwise acquire  
any real or personal property including franchise or license which this  
company may find suitable or convenient for any of the purposes of  
its business.

The corporation is to have a perpetual existence.
