

ARTICLES OF INCORPORATION
OF
THE SOUTHEASTERN IDAHO FAIR ASSOCIATION, LIMITED.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho.

AND WE HEREBY CERTIFY:

FIRST. That the name of said corporation is THE SOUTHEASTERN IDAHO FAIR ASSOCIATION, LIMITED.

SECOND. That the purpose for which it is formed is to establish and maintain a Fair Association at Blackfoot, in the County of Bingham, and State of Idaho, to encourage and promote the various business interests of Southeastern Idaho; to exhibit to the general public the products of the farmers, stockraisers, miners, and other industries; to own and control such real and personal property as may be necessary to successfully carry on the business of the corporation; to lay out a race course and construct such buildings and improvements as may be necessary for the entertainment of the public; to grant franchises and licenses and privileges to individuals to sell the various articles of merchandise incidental to and necessary for such exhibitions and entertainments, and to do any and all things necessary to the full exercise of its powers as herein set forth.

THIRD. That the place where the principal business is to be transacted is Blackfoot, Bingham County, Idaho.

FOURTH. That the time for which it is to exist is

fifty years from and after its incorporation.

FIFTH. That the number of its Directors shall be nine and the names and residences of those appointed for the first year are:
