ARTICLES OF INCORPORATION

OF

RONALD G. ELLIS FARMS, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation.

ARTICLE I.

The name of the corporation of "RONALD G. ELLIS FARMS, INC."

ARTICLE II.

The period of its duration is perpetual.

ARTICLE III.

The purpose or purposes for which the corporation is organized are for the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE IV.

The aggregate number of shares which the corporation shall have authority to issue is 50 shares of the par value of \$100.00 per share, or a total of \$5,000.00, and all shares of the capital stock of the corporation shall be known as common stock, with each share of stock to be entitled to one vote. All shares are non-assessable.

ARTICLE V.
