ARTICLES OF AMENDMENT TO THE  
RESTATED ARTICLES OF INCORPORATION OF  
YOUNG LIFE  
A NONPROFIT CHURCH ORGANIZATION

Pursuant to the provisions of Article 4.03 <sup>Clerk of the Texas</sup> ~~Corporations~~ <sup>Section</sup>  
Non-Profit Corporation Act, the undersigned corporation adopts  
the following Articles of Amendment to its Restated Articles of  
Incorporation, the effect of which is to irrevocably dedicate the  
corporation's property, assets, net earnings and income to  
charitable and religious purposes.

1. The name of the corporation is Young Life.
2. The following amendment to the Restated Articles of  
Incorporation was duly adopted by the corporation as of January  
31, 1983:

The Restated Articles of Incorporation of Young Life  
are hereby amended by adding thereto the following sentence as  
the first sentence of Article V, Paragraph (a): "Notwithstanding  
any other provisions hereof to the contrary, the property,  
assets, net earnings and income of Young Life are irrevocably  
dedicated to exclusively charitable and religious purposes."

3. The amendment was adopted in the following manner:  
The amendment was adopted by the unanimous written consent of the  
board of trustees dated as of January 31, 1983, there being no  
members having voting rights in respect thereof.
