ARTICLES OF INCORPORATION

of the

THE CENTERVILLE CANAL COMPANY

ARTICLE ONE:

/all being citizens of the United States and at least 21 years of age,

This certifies that the undersigned have this day formed a Corporation for the purpose herein after specified and which shall be known as THE CENTERVILLE CANAL COMPANY, with the powers and privileges allowed Corporations by law.

ARTICLE TWO:

The object for which this corporation is formed is for the purpose of taking water from what is known as the Fairview Canal, same being a lateral from the Burgess Canal, and from the Harrison Canal, and carrying the same by a canal twelve feet wide on the bottom, and three feet deep, commencing at a point, fifteen rods East of the North West Corner of Section One in Township Three North of Range thirty-eight East of Boise Meridian, where its headgates are located and running from thence in a general south westerly direction across section one, section two, section three, section nine, section ten to the section eight, thence south one half mile, said water to be used for domestic, agricultural, and other useful purposes, and to buy, hold or sell such real estate as the Company may need in conducting its affairs.

ARTICLE THREE:

The principal place of business shall be Coltman, Bonneville County, Idaho.

ARTICLE FOUR:

The term of the existence of this corporation shall be fifty years from the date of these articles.

ARTICLE FIVE:

The officers of this company shall be a President, Secretary, and Treasurer. The number of Directors shall be three with full powers to manage and control the affairs of the Corporation as provided by law.

ARTICLE SIX:

The capital stock of the corporation shall be ten thousand dollars (\$10,000) divided into shares of twenty-five dollars each which shall be assessable in conformity with the laws of Idaho, when so determined by a majority of the Directors of the Corporation.

ARTICLE SEVEN:

The names and addresses of those who shall manage the affairs of the corporation until the first annual meeting to be held the second Monday of March, 1948, shall be as follows:
