## ARTICLES OF INCORPORATION

OF

SAGA FOUD SERVICE OF IDAHO, INC.

KNOW ALL MEN BY THESE FRESENTS, that we, the undersigned being natural persons of full age and citizens of the United States, in order to form a corporation for the purposes hereinafter stated, under and pursuant to the provisions of the Idaho Business Corporation Act, and the acts amendatory thereto and supplemental thereto, do hereby certify as follows:

FIRST: The name of the corporation is Saga Food Service of Idaho, Inc.

SECOND: The nature of the business of the corporation and the objects or purposes to be transacted, promoted or carried on by it are as follows:

To conduct the business of preparing food for human consumption, serving and selling the same as a caterer, as a concessionaire or as the owner, operator, lessee, of a restaurant, lunchroom, tea room, diner, snack bar, or any similar or like operation,

To purchase, lease or otherwise acquire, and to hold, own, sell or dispose of real and personal property of all kinds which may be necessary, convenient and suitable for the conduct of the business hereinabove described,

To borrow money for its corporate purposes and to make, accept, indorse, execute and issue promissory notes, bills of exchange, bonds, debentures or other obligations from time to time for the purchase of property or for any purpose in and about the business of the corporation and as deemed proper, to secure the payment of any such obligations by mortgage, pledge or otherwise,

To buy, lease or otherwise acquire and thereafter to carry on, the business of any person, firm or corporation or stock thereof engaged in any business which this corporation is authorized to carry on,

To enter into, make, perform and carry out contracts of every sort and kind which may be necessary or convenient for the business of the corporation or business of a similar nature with any person, firm or corporation or any unit of government,
