ARTICLES OF INCORPORATION ETARY OF STATE

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is TABLE ROCK SANDSTONE, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are:

- 1. To quarry, cut, sell and deal in sandstone to be used for any and all purposes including homes, buildings and landscaping.
- 2. To transact any and all lawful business for which corporations may be incorporated under the laws of the State of Idaho.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is one thousand (1,000) shares of the par value of One Hundred Dollars (\$100.00).
