each being persons of legal age, resident of the State of Idaho, and citizens of the United States, associate ourselves together with the intention of forming a non-profit cooperative association under and by virtue of the powers conferred by Title 30 of Chapter 10 of the Idaho Code,

AND WE DO HEREBY CERTIFY

I.

The name of this association shall be IDAHO STATE FLORIST ASSOCIATION, INC.

II.

That the purposes for which the said non-profit corporation is formed are:

1. Through unity and strength to promote progress in floriculture and horticulture in the State of Idaho so that these industries and the people of these industries may better serve the people of Idaho and thereby promote the welfare of the industries. Also to work with and assist any regional or national floral organizations that are endeavoring to help and strengthen the industry.

2. To promote and maintain high standards of conduct in the florist profession as expressed in the Code of Ethics of the NATIONAL ASSOCIATION OF FLORISTS.

3. To provide a unified medium for florists and those engaged in the florists profession whereby their interests may be safeguarded and advanced.

4. To engage, employ, retain or contract for services of persons, groups, corporations or partnerships to act on behalf of said association in raising funds, maintaining an office and employees, contracting interested groups or individuals dealing with the promotion of matters set forth herein.

5. To publish, reprint, distribute, disseminate or make available all forms of educational material dealing with the materials described above.

6. To own, lease, buy, or sell or in any manner deal with real and personal property as may be necessary or convenient for the purpose of the association or any business operated by the association incidental thereto.

7. To borrow money of any person, firm or corporation and to issue notes, bonds, debentures or any other obligation of this association from time to time therefore for any of the purposes or objects of this association, and to secure payment of the same by mortgage, pledge, deed of trust, or other lawful means.

8. To do each and every thing necessary, suitable or proper for the accomplishment of any one or more of the purposes or the attainment of any one or more of the objects herein enumerated, or conditions to, or expedient in, the interests of and the benefits to this association, and contract accordingly, with any person, firm or corporation, both governmental and private and in addition, exercise and possess all powers, rights or privileges necessary or incidental to the purposes for which this association is organized or to the activity in which it is engaged; and in addition, any other rights, powers and privileges, granted by the laws of the State of Idaho to any corporation, except such as are inconsistent with the express provisions of Title 30, Chapter 10 of the Idaho Code, and do any such things anywhere.

9. To use or employ any of its facilities, for any lawful purpose providing that the proceeds arising from such use and employment, shall go to reduce the cost of its use to its members and shall in no way inure to the profits of any member.

III.

The original members of this corporation shall be all those persons who were bona fide members in good standing of the IDAHO STATE FLORIST ASSOCIATION, INC., incorporated on the 25th day of August, 1978, and such other person who may be in the future admitted to membership in the association in accordance with the constitution and by-laws of this association, it being specifically provided that the said corporation may provide for the admission of such future members in the manner and method and under the authority of Section 30-1108 Idaho Code. Membership in the corporation shall be evidenced by certificates of membership, which certificates shall be non-transferrable, and subject to revocation or termination as provided in the constitution or by-laws of the said corporation.

IV.

The period of existence and duration of the life of this association shall be perpetual.

V.

The location and post office address and the principle office for the transaction of business of this association shall be located at 1250 Overland Avenue, Burley, Idaho, 83318, and its registered agent is Phyllis Goicoechea, 121 3rd Avenue West, Gooding, Idaho 83330

VI.

That the corporation shall be managed by a board of nine directors, which board shall have charge and management of the Idaho State Florist Association, Inc., and personal property of the corporation, and the promotion, operation and management of said corporation. That its officers shall be: President, First Vice President, Second Vice President, Secretary-Treasurer, General Chairman of the B.B. and P. R. Committee, Co-Chairman of the B.B. and P. R. Committee and the three most recent past Presidents.

VII.

That in accordance with the provisions of Section 30-1102 Idaho Code, an election was held on the 25th day of August, 1978, for the purpose of electing the directors of the board under which said corporation elects to operate, being as heretofore stated nine in number; said election being held at the Ponderosa Inn, Burley, Idaho at 11:00 o'clock a.m.; that a notice of the time and place of holding of said election of directors was given by publication of notice to said effect two weeks in advance of said meeting (i.e., by two notices with one week elapsing between the first and second notices) in the South Idaho Press, Cassia County, Idaho, a newspaper published in the City of Burley, Idaho; that at such meeting a majority of the members present voted for and there was elected as directors of the said Corporation the following persons, to-wit:
