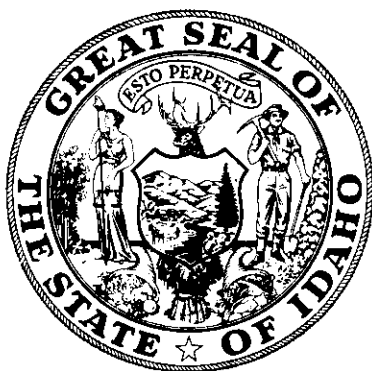

ARTICLES OF INCORPORATION

OPEN DOOR CHRISTIAN FELLOWSHIP, INC.

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Open Door Christian Fellowship, Inc.

SECOND: Open Door Christian Fellowship, Inc. shall be conducted as a non-profit corporation.

THRID: The period of its duration is perpetual.

FOURTH: The purpose or purposes for which the corporation is organized are: to assemble and congragate as Christians to study the Bible.

FIFTH: The corporation shall have members.

SIXTH: The address of its intitial registered office and the name of its initial registered agent at such street address is 10543 Ogden, Boise, Idaho 83709, and the name of its official registered agent is Kim Scott.
