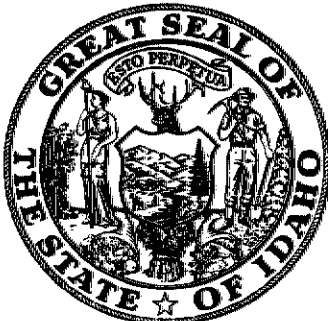

ARTICLES OF AMENDMENT OF  
ENVIRONMENTAL NEWS NETWORK, INC.

ARTICLE I  
NAME

The name of this corporation is ENVIRONMENTAL NEWS NETWORK, INC.

ARTICLE II  
AMENDMENTS

Article 4 of the Articles of Incorporation of said corporation shall be amended by deleting it in its entirety and substituting therefor the following:

"4. Stock. The Corporation shall have the authority to issue three million (3,000,000) shares of capital stock, all of one (1) class, having a par value of one dollar (\$1.00).

ARTICLE III  
DATE OF ADOPTION

The Amendment has been approved by all of the shareholders of said corporation at a meeting held on the 18th of May, 1996, at which meeting there was at all times an acting quorum of the shareholders.


ARTICLE IV  
NUMBER OF SHARES OUTSTANDING

At the time of the adoption of the Amendment there were 19,692 outstanding shares of the stock of the corporation, all of which shares entitled to vote and did vote in favor of the Amendment.

ARTICLE V  
EFFECT ON ISSUED SHARES AND STATED CAPITAL

The Amendment does not provide for an exchange, reclassification or cancellation of issued shares, nor does it effect a change in the amount of stated capital.
