ARTICLES OF INCORPORATION  
OF  
CAMP AMERICA, INC.

ARTICLE I.

The name of the corporation shall be Camp America, Incorporated.

ARTICLE II.

The period of duration is perpetual.

ARTICLE III.

The purpose of this corporation is to manufacture, purchase, or otherwise acquire, own, mortgage, pledge, sell, transfer and assign, or otherwise dispose of, to invest, trade, deal in and with, goods, wares, merchandise and real or personal property of every class and description and any and all lawful business for which corporations may be incorporated under this act.

ARTICLE IV.

The management of this corporation, the conduct of it's affairs, and the powers, duties, and privileges of it's directors, officers and membership shall be set forth in the approved by-laws and any approved amendments hereto or hereof as required under the laws of the State of Idaho.

ARTICLE V.

The amount of the total authorized capital stock of Camp America, Inc. shall be 100 shares of common stock with a par value of one dollar (\$1.00) per share.

ARTICLE VI.

The shareholders are hereby granted preemptive rights pursuant to the Idaho Code 30-1-162.

ARTICLE VII.

The initial registered office of Camp America, Inc. is located at the Law Office of Nick Chenoweth, 126th and Highway 12, Orofino, Idaho, and the registered agent being Nick Chenoweth.


