## KNOW ALL HEN BY THESE PRESENTS

That we the undersigned, a majority of whom are free holders citizens and residents of the State of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho.

And we do hereby certify:

First: That the name of said corporation shall be THE NORTH EXTENSION CANAL COMPANY, LIMITED.

second: That the purposes for which it is formed are to have and to hold real estate and personal property: to construct head gates, dams and ditches: to put in bridges, boxes and for all other purposes necessary for irrigation and agricultural purposes and for the purpose of generating power for mills and for electric power, etc.

Third: That the place where the principal business of the corporation is to be transacted is Turner, Bannock County, Idaho.

Fourth: That the term for which said corporation is to exist is fifty (650) years from and after the date of its incorporation.

pifth: That the number of directors or trustees of said corporation shall be five (5) and that the names and residences of the Directors of Trustees who are appointed for the first year, a majority of the members being present and woting and to serve until the election and qualification of such officers are as follows, to wit:
