DISCONTINUING THE ORGANIZATION OF THE VILLAGE OF
WENDELL, IDAHO, AS A VILLAGE AND ORGANIZING IT AS
A CITY OF THE SECOND CLASS:

It satisfactorily appearing to the Chairman and Board of Trustees of the Village of Wendell. Idaho, in regular session assembled, that the Village of Wendell, Idaho, contains more than 1000 inhabitants and desires to discontinue its organization as a village and to organize as a city of the second class, and that a written petition seeking such discontinuation and organization, signed by qualified electors of said village exceeding three-fifths of the total vote as shown by the last preceding general village election held in said village (April, 1945), has recently been filed with the village clerk of said village, and such petition appearing to be properly signed and filed and in order:

Now. Therefore, BE IT RE-SOLVED by the Chairman and Board of Trustees of the Village of Wendell, Idaho, that the organization of said village as a village shall be and hereby is discontinued, and it hereby is organized as a city of the second class, and shall henceforth be known as the "City of Wendell Idaho".

Passed and approved unanimously by the Chairman and entire Board of Trustees of the Village of Wendell. Idaho this 14th day of February, 1947.
