KNOW ALL PERSONS BY THESE PRESENTS: That, we the undersigned being natural persons of full age and citizens of the United States of America, in order to form a corporation. for the purposes hereinafter stated, pursuant to the laws of the State of Idaho, do hereby certify as follows:

ARTICLE ONE NAME

The name of this educational corporation shall be The Orofino Braille Transcribers, Inc.

ARTICLE TWO STATUS

The corporation is a nonprofit educational corporation.

ARTICLE THREE AUTHORIZATION

This corporation shall proceed under Chapter 3, Title 30 of the laws of the State of Idaho.

ARTICLE FOUR PURPOSES AND POWERS

The purposes for which the corporation is organized are as follows:

To promote and teach the transcribing of printed or written words and numbers into Braille and any and all other matters pertaining thereto.

ARTICLES OF INCORPORATION - 1

ARTICLE FIVE MEMBERS

This corporation shall have a Board of Directors of not less than three nor more than seven who shall manage the affairs of the corporation pursuant to Sec. 30-314, Idaho Code and shall have the power to elect successive directors and additional directors. It shall also have the power to appoint members of the corporation.

ARTICLE SIX PRINCIPAL OFFICE

The post office address of the principal office of the corporation in the State of Idaho is Hospital North Drive #23, Orofino, Idaho 83544.

ARTICLE SEVEN REGISTERED OFFICE AND REGISTERED AGENT

The address of the corporation's initial registered office in the State of Idaho is Hospital North Drive #23, Orofino, Idaho 83544. The name of the corporation's initial registered agent at such address is Dennis Bodily.

ARTICLE NINE DIRECTORS

This corporation shall be nonstock, and no dividends or pecuniary profits shall be declared or paid to the members thereof.

ARTICLE ELEVEN DURATION

The duration of the corporation shall be perpetual.
