



ARTICLES OF INCORPORATION
OF
BLUE GOOSE ENTERPRISES, INC.

The undersigned, acting as incorporators under the Idaho Non-Profit Corporation Act, adopt the following Articles of Incorporation.

ARTICLE I

The name of the corporation is Blue Goose Enterprises, Inc.

ARTICLE II

This corporation is organized as a non-profit corporation.

ARTICLE III

The period of duration is perpetual.

ARTICLE IV

The purpose for which this corporation is organized is exclusively charitable as defined by Section 501 (c) (3) of the Internal Revenue Code of 1954 (or the corresponding provisions of any future Internal Revenue Code); the charitable purpose will consist of the following:

1. To provide a resource for mentally or emotionally ill individuals who can benefit from social, vocational, educations, rehabilitative and recreational activities in the community;

2. To provide a forum for mentally and emotionally ill individuals and persons interested in issues regarding the mentally or emotionally ill to share their skills and abilities with each other and the general public with the goal of reducing the stigma attached to the label mental illness;
3. To provide a forum for consumers of health care services to respond to the providers of those services;
4. To provide training opportunities for students enrolled in social work, nursing, or health-related education programs to observe, interact with, and learn from individuals suffering from mental or emotional illness;
5. To provide housing opportunities for individuals who suffer from mental or emotional illness, but who do not need to be confined in the hospital;
6. To assist individuals with mental or emotional illness with self-care skills including, but not limited to, financial planning, budgeting, diet and nutrition, housekeeping, and consumer awareness;
7. To serve as a clearinghouse for information concerning the variety of public and private agencies offering assistance to mentally or emotionally ill individuals;
8. To raise money and seek donations to assist the charitable objectives of the Blue Goose Enterprises, Inc.;
9. To advocate on behalf of individuals suffering from mental or emotional illness; and,
10. To enter into contracts consistent with the charitable objectives of Blue Goose Enterprises, Inc.

ARTICLE V

The corporation shall have one (1) class of members.

Members shall consist of individuals who are participants in Blue Goose Enterprises, Inc. and staff members of the Idaho

Department of Health and Welfare Mental Health staff. The number and qualifications of the members shall be further enumerated in the bylaws of the corporation. Management of the corporation is vested in its membership pursuant to Idaho Code §30-3140 (c).

ARTICLE VI

Membership in the corporation shall not be represented by capital stock or certificates of membership.

ARTICLE VII

Upon dissolution of the corporation, the members shall, after paying or making provisions for the payment of all the liabilities of the corporation, dispose of its assets to federal, state or local government for a public purpose or to other charitable organizations which qualify as tax exempt organizations pursuant to Section 501 (c) (3) of the Internal Revenue Code of 1954 (or the corresponding provisions of any future Internal Revenue Code), as the members shall determine.
