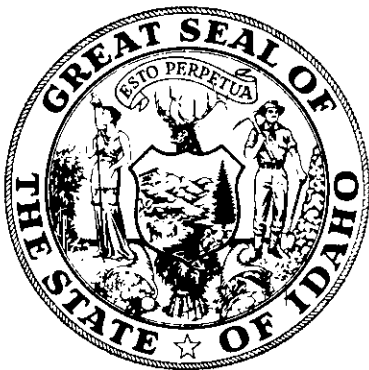

Pursuant to Section 30-1-61 of the Idaho Business Corporation Act, Leeming Construction, Incorporated, an Idaho corporation, hereby files these Articles of Amendment and represents as follows:

1. The name of the corporation is Leeming Construction, Incorporated, an Idaho corporation.

2. The amendment adopted by the Shareholders is to change the name of the corporation from Leeming Construction, Incorporated, to Parallel Dimensions, Inc., an Idaho corporation.

3. The amendment to the name of the corporation was adopted by the Shareholders on November 3, 1988, by unanimous vote of all of the Shareholders of the corporation. There are 1,000 shares of common stock issued and outstanding and entitled to vote on said matter.


