Article 1: Corporation Name
Entity name Hope Reins Foundation Inc.
Article 2: Effective Date
The corporation shall be effective when filed with the Secretary of State.
Article 3: Purpose
The purpose for which the corporation is organized is: General Nonprofit
Article 4: Voting Members:
The corporation does not have voting members.
Article 5: Asset Distribution on Dissolution
Upon dissolution the assets shall be distributed: other asset distribution:
Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions.
Article 6: IRS Designation
Is this nonprofit a 501(c)3? Yes
501(c)3 purpose for which the corporation is organized: an equine assisted psychotherapy and therapeutic riding for adolescents, children, families, veterans, and corporate groups. Further, said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
