ARTICLES OF AMENDMENT OF THE ARTICLES OF INCORPORATION
OF THE TWIN FALLS CHAMBER OF COMMERCE, INC.

Amendment of the Articles of Incorporation of the Twin Falls Chamber of Commerce, Inc., a non-profit corporation organized under the laws of the State of Idaho, executed by C. Barney Carlson of 244 Larkspur Drive, City of Twin Falls, County of Twin Falls, its President, and Michael Dolton of 108 Larkspur Drive, City of Twin Falls, County of Twin Falls, its Secretary.

- 1. That the name of the corporation be changed to the Greater Twin Falls Area Chamber of Commerce.
- The corporation was organized and a certificate of incorporation was issued on the 12th day of January, 1935.
- 3. The corporation, on the proposal of its Board of Directors by resolution duly adopted by said Board of Directors setting forth the proposed amendment and directing that the same be submitted to a vote of the members entitled to vote in respect thereof at the annual meeting of such members and an adotpion by a majority of those present as provided by law, does hereby, by C. Barney Carlson, its President, and Michael Dolton, its Secretary, executed and acknowledge the following:

That paragraph 4 of the original Articles of Incorporation is hereby changed to read as follows:

"That the term of the existence of said association is to be perpetual"

3. The above amendement has been adopted by a majority of the members entitled to vote thereon at the annual meeting held the 31st day of January, 1985, as required by the laws of the State of Idaho, the Articles of Incorporation and the By-laws of the corporation. That a quorum was present at said special metting and the vote of approval was unanimous.
