ARTICLES OF AMENDMENT

Pursuant to Idaho Code §30-1-61, and the authority of resolution of shareholders and directors of the corporation dated the 20th day of December, 1985, the undersigned officers of the corporation render these Articles of Amendment and represent as follows:

(a) Name of the Corporation: Paul Jensen and Associates, Architects, P.A.

(b) Amendment adopted: That Article I of the Articles of Incorporation of Paul Jensen and Associates, Architects, P.A., be amended to read:

NAME: The name of the corporation is Jensen, Ratzlaff & Unrau, Architects, P.A.

(c) Date of adoption of amendment by shareholders - December 20th, 1985.

(d) Share outstanding - 251 shares are outstanding and entitled to vote on the amendment, individually and not as a class.

(e) Share Voting - 251 shares voted for the amendment; none against.

(f) Exchange of Shares - Such appropriate exchange of certificates evidencing ownership in the corporation shall be made so as to preserve the existing shareholder interests in the corporation and so as to provide shareholders with certificates properly designated in the new name of the corporation.
